- 1. The meeting was called to order by Mr. Spilde at 5:32 p.m.
- 2. Welcomes and introductions were made.
- 3. The minutes of the October 06, 2021, Metropolitan Planning Organization (MPO) Policy Council meeting were presented. A motion to approve was made by Mr. Weld, seconded by Mr. Dunning and passed unanimously.
- 4. The minutes of the January 12, 2022, MPO Technical Advisory Committee meeting were accepted as information.
- 5. Mr. Anderson presented the proposed Amendment #1 to the 2022-2026 Transportation Improvement Program (TIP) for the Eau Claire Urban Area. This amendment includes the addition or modification of eight highway projects and five transit projects. After a brief explanation of the projects included in the amendment, a motion for a resolution to approve the amendment was by Mr. Dunning, seconded by Mr. Weld, and passed unanimously.
- 6. Mr. Anderson presented the proposed Amendment #2 to the 2022-2026 Transportation Improvement Program for the Eau Claire Urban Area. This amendment changes the upper target for vehicles in service which have exceed their "useful life" from 48 percent to 51 percent. This change brings the service into agreement with the State of Wisconsin Transit Asset Management plan. A motion for a resolution to adopt the amendment by the MPO was made by Mr. Brennan, was seconded by Ms. Roberts, and passed unanimously.
- 7. Mr. Anderson presented updates on several projects in which the MPO is currently engaged.
- 8. Other Business: The recently released Wisconsin Department of Transportation (WisDOT) Request for Proposals for projects to be funded under the Bipartisan Infrastructure Bill (BIL) was discussed.

The goal for the first round of funding being dedicated to "shovel-ready" projects was discussed and the suitability of various projects within the MPA was discussed. The types of projects that might be considered under future rounds of funding were also discussed. Mr. Rothrock will forward to the council members guidance issued by the federal government regarding the BIL funding programs. Also, Mr. Anderson briefed the Council on an ongoing conversation the MPO staff is having with WisDOT regarding improving pedestrian safety at the intersection of Highway 12 (Clairemont) and Otter Road, the site of a recent pedestrian fatality. He advised that staff had expanded the discussion to the issues along the entire stretch of the highway through the MPA and how he had shared the concerns of elected officials, professional staff at the various jurisdictions, as well as the feedback from the public gathered through several projects in which the MPO has recently been engage.

The amount of funding available from WisDOT will be announced shortly, after which ranking of the applications and staff recommendations for grant awards can be produced. The special meeting is required to allow those recommendation to be approved the TAC and then included on the MPO Policy Council agenda for the meeting scheduled for May 4.
  - Mr. E. Anderson presented recently received guidance on the current round of the Transportation Alternatives Program grants regarding timing and resubmissions.

- 2. Welcome and introductions
- 3. The minutes of May 13, 2022, TAC meeting were approved by all following a motion by Mr. Walter, seconded by Mr. F. Anderson.
- 4. Mr. E. Anderson presented scoring and ranking for the grant applications for projects located in Chippewa-Eau Claire MPA for funding under the Bipartisan Infrastructure Law STP-Urban program. The final amount of funding for the program has not been shared from WisDOT, but the MPO staff has been told by WisDOT that it will be very close to \$1,500,000. That amount was used to build the scenarios.

For the three projects submitted, three funding scenarios were considered by the Committee. The first two were presented by MPO staff, the third was requested by Committee members:

- i. All projects would receive an equal percentage of their total project costs, estimated to be 64.5%.
- ii. The top ranked project would receive the maximum 80% of total project costs. The second and third ranked projects would each receive the same percentage from the remining funds, estimated to be 60%.
- iii. The top two ranked projects would each receive 80% of their project costs, the lowest-ranked project would receive the remaining funding, estimated to be 57% of the project costs.

After a brief discussion, a motion to recommend Scenario ii. to the MPO Policy Council was made by Ms. Ness, seconded by Mr. Walter, and approved by all.

AMENDMENT NUMBER 3 TO THE TRANSPORTATION IMPROVEMENT PROGRAM FOR THE CHIPPEWA-EAU CLAIRE URBANIZED AREA (2022-2026).

**WHEREAS**, the Chippewa-Eau Claire Metropolitan Planning Organization (MPO) was designated by the Governor of the State of Wisconsin for the purpose of carrying out cooperative, comprehensive, and continuing urban transportation planning in the Eau Claire urbanized area; and

**WHEREAS**, all transportation projects in the Eau Claire urbanized area which are implemented with federal funds must be included in the annual elements of the Transportation Improvement Program (TIP) and approved by the MPO is a prerequisite for funding approval; and

WHEREAS, the 2022-2026 TIP was approved by the Chippewa-Eau Claire MPO in October 2021; and

**WHEREAS**, this amendment includes the addition or modification of eight highway projects to the 2022-2026 TIP, as attached; and

**WHEREAS**, the MPO has adopted and followed procedures for amendments to make such changes to the program; now therefore

**BE IT RESOLVED BY THE CHIPPEWA-EAU CLAIRE METROPOLITAN PLANNING ORGANIZATION:** That the Chippewa-Eau Claire MPO approves the major amendment to the 2022-2026 TIP and that the

newly added and modified projects are formally adopted, as attached.
